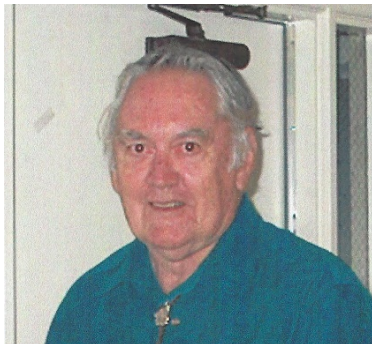
While working towards his Master's degree, Jene met Isabelle Forbusch, who was also completing her Master's. They were married on August 17, 1958.

By 1964 Jene & Isabelle had joined a couple of German Shepherd Dog clubs, had their first shepherd, and attended/helped at many specialties. They got Brimhall's Tracy in 1981 and in

the spring of 1982, Tracy got her first points. After that, they were hooked. It wasn't long before you would find them running home from their jobs at the Laurence Livermore Labs on a Friday night, putting the dogs into their packed and ready fifth-wheel trailer, and off to the dog shows they would go.

Over the years, Jene and Isabelle owned, co-owned and/or bred multiple US and Canadian Select Champions, Grand Champions, Futurity and Maturity winners and ROMs. Over the past couple of decades, Jene gave countless hours to local specialty clubs and at herding trials, helping wherever he could. He is probably best known for his iced tea at herding trials & chili at the specialty shows.

Jene and Isabelle especially loved the GSD for their working abilities and put herding titles on many of their dogs. When the local herding trainer lost the lease on her facility, Jene and Isabelle purchased a 9-acre property in Vacaville which is now "Herding 4 Ewe", also affectionately known as "The Dupzyk Ranch".



Jene touched the lives of so many, always greeting friends, old and new, with a sincere smile and a kind word. He will be remembered as a loving husband and friend. He will be deeply missed.

EXHIBITOR RULE CHANGE EFFECTIVE 01/01/2011

Chapter 11, Section 1. No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. *For complete details see Rules Applying to Dog Shows, Chapter 11, Section 1.*

4-6 MONTH BEGINNER PUPPY ENTRIES CLOSE SATURDAY JANUARY 11, 2020 AT 9:00 AM LOCAL TIME

- The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign-born dog may enter this class if they are registered in the country of origin
- Professional handlers are not permitted to exhibit in this class. Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler.
- All of the puppies of the same breed (not divided by sex) are exhibited in the same class and the only placements are Best of Breed and Best of Opposite Sex to Best of Breed

RULES OF THE GOLDEN STATE GSDC of SAN JOSE

1. IF MONEY IS OWED TO GOLDEN STATE GERMAN SHEPHERD DOG CLUB OF SAN JOSE, ENTRIES AND PERSONAL CHECKS WILL NOT BE ACCEPTED UNTIL ALL MONEY OWED IS REMITTED BY MONEY ORDER OR CASHIERS CHECK. RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY.
2. The club assumes no responsibility for a wrong entry. Please PRINT or TYPE all information on entry blanks.
3. During the hours of judging, owners are to be on call and to have their dog ready to be brought into the judging ring promptly so the judging will not be delayed.
4. It is the responsibility of the exhibitor to have his or her dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs are alone responsible for the presence of their dogs in the judging rings.
5. There is no rule of this Club or of the AKC that requires a judge to wait for an owner or handler to bring his or her dog into the ring.
6. An exhibitor whose dog is eligible for an award must be present or have an appointed representative to accept the award for him or her.
7. Entry fees will not be refunded if the dog is absent, disqualified, sick, lame, in season, excused by veterinarian or judge, or barred from competition by action of the show committee.
8. Exhibitors and handlers will be held responsible for clean conditions in and around their crates.
9. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is understood that the exhibitor will exercise control over his or her children on the day of the show.
10. The Club assumes no responsibility for dogs or equipment left unattended.
11. All dogs must be kept on leash.

AKC CODE OF SPORTSMANSHIP

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
